SUBMISSION RULES - PLEASE READ CAREFULLY

1. Submissions will only be accepted for people who will be attending this conference. If your song is chosen and you are not registered for the conference, your song will be disqualified.
2. ONE SONG ONLY per writer - no exceptions.
3. Songs must be recorded in a CD format and mailed to the address listed below. No songs will be accepted via e-mail or other electronic format. Please include lyrics with chords (lead sheet/music preferred).
4. All songs must be original works fully owned by the participant(s). Songs can be co-written if both writers are attending the conference.
5. We are looking for congregational liturgy & worship songs, not "artist" songs.
6. Songs must not have been previously released in wide distribution.
7. Each song must be copywritten by the owner and clearly marked. We cannot accept any non-copywritten submissions.

We realize that the copyright process can be delayed. If you have applied for copyright, don't wait to submit your song until you get your final paperwork, simply right "Copyright pending" on your paperwork. For simple copyright instructions go to <http://copyright.gov/register/performing.html>.

8. The owners of each selected work will be contacted prior to the conference to take care of any legal contracts (writer retains ownership).

9. Submitted materials cannot be returned.

10. Each submitted work must be accompanied by the above form and the Leading With Passion! 2006 License Agreement that is included on the following page.

11. Due to the volume of songs we receive, we will not be able to verify receipt of your package. It is not required, but might be more reliable if packages are sent via UPS, FedEx, or some other way that will verify delivery for you.

License Agreement

The following license agreement is entered into on this _____ day of _____, 2006 between Wings Music Ministry and the songwriter(s) _____.

Should Wings Music Ministries (WMM) / *Leading With Passion!* (LWP!) select the song _____, submitted, composed and fully owned by the above songwriter(s) for inclusion in our *Leading With Passion!* Unity Concert 2006 and CD, the following specifics are noted:

1. The live recording will take place during the closing *Leading With Passion!* Worship Music Conference + Festival - Unity Concert. However, all winning songwriters are expected to be registered attendees of the conference.
2. The song will be arranged and produced by LWP and selected musicians and vocalists.
3. Every effort will be made to retain the original arrangement and structure intentions of the composer with the following considerations:
 - a. Instrumentation will be decided on by the music director as selected by LWP
 - b. Lyrics will not be intentionally altered without permission from the writer
 - c. Chord progressions will not be altered unless minor changes are deemed necessary by the music director. In the event that any major changes are made, songwriter will be consulted first
 - d. Complicated song arrangements or vocal arrangements may be simplified at producer's discretion to optimize the congregational usability of the song for the average church
 - e. Final arrangement decisions will be made by the producer. Major changes will not occur without first consulting the writer.
4. Writer will retain 100% ownership of all publishing and copyrights for his/her song.
5. The song will ultimately be mixed and pressed to CD. The CD may be offered royalty free to all conference attendees at no additional cost. Each songwriter will receive 10 copies of the final CD (10 per song).
6. Sheet Music for all included songs will be made available.
7. Wings Music Ministry will retain ownership of the Master Recording only. Copies of this recording will be subject to all known copyright laws.
8. Songwriter is granting permission to WMM/LWP and/or affiliates to use the CD and sheet music royalty free in perpetuity for promotional and ministry purposes.
9. The intention of WMM/LWP! is not to sell the CD as a product for the general public. However, WMM/LWP! will retain the right to offer additional royalty free copies (after the free copies for attendees of the 2006 Conference) on the website or at future conferences to cover costs. If product becomes in-demand and WMM/LWP is prompted to run more units for sale purposes, songwriters will be contacted.
10. WMM/LWP! is incurring all costs associated with the preparation, recording and manufacturing of the CD, songwriter waives the right to all mechanical royalties associated with this CD and the Sheet Music for this project only. However, since songwriter retains 100% ownership of their work, he/she is free to use their song on any other project with no obligation to WMM/LWP!.
11. Writer acknowledges that he/she is the sole copyright owner of the song and that there are no third parties with any interest.
